Two Rings and one judge. Open to all Breeds and Mixed Breeds of all sizes.

Classes offered Monday:

Instinct Test, Novice, Open, Senior, Master and Crazy8

Entries will open to Field Spaniels, Italian Greyhounds and Ibizan Hounds only on July 30th, 2018. Open to all breeds on August 13th, 2018. Entries will be accepted on a first received basis until limits are reached. If limits are not reached by closing on August 31, 2018, we will accept Late entries until September 3rd, 2018.

No Day of Show entries will be accepted.

Crazy 8's will be limited to 25 runs.

Judge:

Entry fees are \$15 for Instinct, \$20 for Novice and Open and \$25 for Senior, Master and Crazy 8's. Late Entries are \$20 for Instinct, \$25 for Novice and Open and \$30 for Senior, Master. and Crazy 8's.

There will be a short lunch break at the judge's discretion. Move ups will be allowed between trials.

EXHIBITOR INFORMATION

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test. Dogs completing the RATN in the morning trial either day may be moved up to Open for the second trial. This is up to the handler and not required. Move-ups will be accepted up until 1/2 hour after the conclusion of the Trial 1. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or by e-mail.

Make check payable to MCAC. Send entries and fees to the trial Secretary; Jollette Wojdyla, 9014 Pine Avenue, St. Louis, MO 63144.. Dogs must have a Barn Hunt Registration number. Refunds will be made in full if a dog is pulled before 8/31/18 pre-entry closing date but not after - except for a veterinary excuse.

Please be aware of the rules for Barn Hunt trials. Rules may be found at www.barnhunt.com. All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES, ELECTRONIC COLLARS, PINCH/PRONG COLLARS AND HEAD HALTERS ARE NOT PERMITTED** at the trial site. Please pick up after your dog and dispose of waste in appropriate containers. There is NO SMOKING in the Purina facilities or on the grounds.

Judging start: 8:00 AM

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

AWARDS: Ribbons will be awarded for all qualifiers in the Instinct test and all regular classes. Ribbons will be awarded for first through fourth place for qualifiers in Novice through Master. High in Class ribbons and new title ribbons will also be awarded.

SPECIAL AWARDS;

For Trial #1, for first place and High in Class, a stuffed toy (all breeds). For Field Spaniels a High in Class a Slip or Clip Fleece Tug Lead.

For Trial #2, for first place and High in Class, a stuffed toy (all breeds). For Field Spaniels a High in Class will get a stuffed toy.

Italian Greyhounds will be giving out a stuffed rat for High in Class (Italian Greyhounds only). Also any Italian Greyhound that earns a RATCH will get a special gift.

These trials will be held outdoors under a pavilion. Crating in your vehicle is a possibility and might be encouraged depending on time of arrival. There is plenty of green space to crate at the site as well. Please make sure your crate is secure as dogs may be highly excited and the nearby grounds are not fenced in.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
