

#### **Ribbons & Prizes**

**Trial:** First=blue, Second=red, Third=yellow, Fourth=white, Fifth=pink, Best of Breed=purple & gold, JC Tests=green flat ribbon

Trophies for 1st in each stage. Prizes 2nd through 5th placements.

#### **Eligible Breed & Registry**

Only Ibizan Hounds, that are one year of age or older, that have been registered with The American Kennel Club, or part of an AKC-registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or of a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP), are eligible to participate in lure coursing tests and trials. Hounds may not be entered as "registration pending" or "ILP Pending." Breed disqualifications apply.

#### **TESTS & STAKES OFFERED**

#### **Test Offered**

**Junior Courser**: Open to eligible Ibizan Hounds. A hound running alone must receive a certification from a Judge on one date, and a second certification from a different Judge at a later date, with each Judge stating that the hound completed a (minimum) 600-yard course with a minimum of 4 turns. The hound must complete the entire course with enthusiasm and without interruption. Ribbons (Dark Green) will be awarded to all hounds that successfully complete the AKC Junior Courser Test.

#### **Qualifying Courser Offered**

Qualifying Courser: Open to eligible Ibizan Hounds. A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed—or another breed with a similar running style (Testing Hound) shall receive certification from a licensed judge. The qualifying hound must complete the course with enthusiasm and without interruption, sufficiently course the lure and not course the Testing Hound. The testing hound must run a sufficient length of the course to allow evaluation of the qualifying hound. If two non-qualified hounds are run together, both dogs can be certified by the judge. It must be understood that if one dog fails to complete the course, the other dog may not qualify. The judge will certify that the Qualifying Hound ran cleanly and did not appear to present a hazard to the Testing Hound at any point in the qualifying course. This certificate is required to enter a hound in an Open Stake.

#### **Stakes Offered**

**OPEN:** Open only to eligible Ibizan Hounds with no breed disqualifications, that holds an AKC QC certificate OR has run in the Open Stake prior to Jan. 1, 2010, OR has a Senior Courser title OR have an ASFA or CKC field champion title. (a copy of this title must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake.

**OPEN VETERAN:** Open only to Ibizan Hounds that are eligible to enter either Open or Special Stake, and are of Veteran age (6 years of age and older). Championship or LCX points may be awarded from this stake.

**SPECIAL:** Open only to Ibizan Hounds that are eligible to enter the Open Stake and have earned their AKC Field Championship title. LCX points may be awarded from this stake. **Hounds under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.** 

**SINGLES:** Open only to Ibizan Hounds. Hounds with breed disqualifications are eligible to enter. Hounds entered in the Singles Stake shall not be allowed to enter the regular stakes. Each hound will be run individually. **LIMITED ENTRY of 10 Hounds! Placements are awarded.** 

#### **NON-REGULAR STAKES\*\*\***

**BREEDER STAKE**: For two Ibizan Hounds, designated at time of entry, bred by the same individual. You may only use a dog once per Breeder Stake the same individual. You may only use a dog once per Kennel Stake.

**BENCH CHAMPION:** For any hound eligible to enter a regular stake, that is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

**PERFORMANCE TITLED:** For any hound eligible to enter a regular stake, that is an AKC, CKC or UKC performance/companion title holder of record (excluding Field Trial Titles). A copy of the hound's title certificate must accompany each entry.

\*If a tie exists after the final runs, the dog(s) with the highest FINAL score will be declared the winner. If the final scored is tied, the dog(s) with the highest Preliminary score will be declared the winner.

#### **Conditions of Entry**

#### ALL ENTRANTS MUST BE ADHERE TO ALL OVID-19 POLICIES AND PROCEDURES

- All entries must be one year of age or older on the day of the trial.
- Hounds not present at the time of roll call will be scratched after a 5 minute grace period and no refund will be given.
- Stakes may be split if sufficient entries are present in any one stake at the time of the draw to support more than one 5-point Major.
- Bitches in season and lame hounds will be excused. Entries will be refunded. These are the only reasons that Early Entries will be refunded after the pre-entry closing date.
- There will be a minimum \$30 returned check charge.
- Hounds will be checked for breed disqualifications. Spayed and neutered hounds are eligible to participate. Monorchid and cryptorchid hounds are ineligible to participate.
- Owners of hounds entered for a QC run are responsible for providing and/or arranging for the additional hound to run with.
- A \$5.00 fine will be assessed for any loose hound on the field that is not competing in the course in progress.
- Battery powered, continuous loop equipment will be used. Lures consist of white plastic.
- Back-up equipment will be available.
- IHCUS reserves the right to alter course due to field and/or weather conditions on the day of the trial.
- Course will be reversed for finals, run-offs and BOB.
- Although the field is completely fenced, it is also used as a pasture for cows and sheep during the week
- Adequate shade and cool/drinking water should be provided by the participants.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Committee. Children **MUST** be under control of their parents or guardians at all times.

Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running in the course in progress will be permitted near the lure machine

## How to enter your dog and earn AKC Titles

- ✓ Your dog must first earn a Qualifying Courser (QC) certification. Be sure to CHECK OFF "QC" ON THE ENTRY FORM.
- ✓ Next, if your dog has practiced successfully with other dogs (not interfering either aggressively OR playfully), you should enter him in Open and work towards the Senior Courser (SC) title. If your dog also wins a placement he will earn points towards his Field Championship (see point scale below). CHECK "OPEN" ON THE ENTRY FORM, AND PAY THE ENTRY FEE FOR OPEN. There is no additional fee for the SC leg. To earn the SC title, the hound must run with at least one other hound, and must receive qualifying scores at FOUR (4) AKC trials under two different judges or judging panels.
- ✓ When your dog has earned the SC title, he most likely will still be competing for Field Championship points. If he receives qualifying scores in 25 trials, he will earn the Master Courser (MC) title.
- ✓ The title of Field Champion (FC) is a prefix to a hound's name. It is earned by obtaining 15 points from the Open or Veteran stakes. Dog must win 2 first placements worth 3 or more points under two different judges or judging panels (majors).
- ✓ A dog who has earned his Field Championship title must be entered in the Special Stake.



- ✓ Stakes shall be split each time the entry is sufficient to hold two (2) or more five (5) point majors. For example: An entry of 12 Open dogs will be split into two stakes of 6 dogs each.
- ✓ Upon request from an owner or owner's agent on either the entry form or at roll call, multiple entries from an owner shall be divided as evenly as possible between the courses if possible. This does not apply to the Best in Field competition
- When there is but a single course in a regular stake in which an owner or their duly authorized agent has more than one hound, these hounds will be run together or one or more will be scratched by the owner or their duly authorized agent, without refund of entry fee.

## **ADDITIONAL NOTES ABOUT QC RUNS**

- ♣ All dogs entering the Open stake must now earn a Qualifying Courser certification. (Unless said hound has run in the open or open veteran stake in a trial prior to Jan. 1. 2010 or was certified by ASFA or holds a field champion title from ASFA or CKC a copy of such certification or title needs to accompany the hound's first trial entry)
- \* You are responsible for finding a hound of like running style to run your QC hound with. You cannot expect to run your hound for a QC without arranging for another hound to help certify yours.
- ♣ You will need a completed "QC" form. You must give this form to the Field Trial Secretary BEFORE the QC runs begin, or mail it with your entry. THIS IS IMPORTANT!
- ♣ Once your hound has completed its QC and the judge has come off the field, please see the Field Trial Secretary to retrieve your certification form. You will need to attach this (or a copy of it) to your hound's first official entry into the Open or Open Veteran stake.
- ♣ The JC test is no longer required AT ALL to enter the open stake and, in fact, a hound may have a JC title but without the QC (or other stated requirements) a hound MAY NOT enter the Open or Open Veteran stake at a trial.
- ♣ If you have any questions about this please contact the Field Trial Secretary
- ♣ We will run ALL JC's, then QC's, then begin the TRIAL. Dogs that have earned their QC may enter the Trial by paying DOS entry fees and entering prior to DOS closing time. A separate entry form is required, and dog must pass trial inspection.

### **NOTES FOR THE WEEKEND**

- ♥ If you have ANY questions about what stakes/tests to enter your dog, e-mail the field trial secretary <a href="mailto:natlcsecretary@ihcus.org">natlcsecretary@ihcus.org</a>
- ♥ Make sure to bring shade and water for your hounds
- ♥ All hounds finishing their QC titles are eligible to run in Open BUT IT IS ONLY ENCOURAGED if they've run more than just the QC with another hound, and have run cleanly without coursing another hound or interfering in any way
- $\P$  Your hound no longer needs a JC to enter a trial but the JC still appears as a title after your hounds name if they earn it.  $\varpi$  There will be a port-a-john on site.
- Please park in the parking lot located prior to the bridge
- ▶ Make sure to pay attention to the running order, your dog's colors, and to the paddock master if your hound is ready and waiting, when it's his turn to run, the trial goes smoother for everyone. Any hound that is more than five minutes late in getting to the line for their course may be excused from competition for the day as per AKC rules.
- ♥ If you are new to the sport, grab someone and ask questions! We're always happy to help "newbies" learn the ropes!
- Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
- ♥ No cigarette smoking on or near the field.
- **DO NOT TURN DOGS LOOSE IN ANY OF THE FENCED AREAS**
- **P** Due to sharing the field with the Greyhounds, we will NOT be breaking for the Hound Specialty.

### **COVID-19 PROCEDURES**

Judges, workers, and exhibitors are <u>required</u> to wear a solid facial covering that completely covers the nose and mouth.

- 1. All members of the Field Committee and Lure Operators will wear facial coverings.
- 2. All participants will wear facial coverings and practice social distancing.
- 3. No food will be served. Please bring your own food, water, and shade for yourself and your dogs.
- 4. We ask that all participants park a safe distance away from one another.
- 5. Roll Call will be performed as usual, with everyone socially distanced. The Inspection Committee will wear gloves and facial coverings. Participants with female dogs will be asked to wipe their dogs and show the wiping material to the Inspection Committee.
- 6. Portable toilets will have their doors propped open when not in use.
- 7. The Huntmaster will stand six feet from the participants after inspecting blankets and slip leads.
- 8. At the starting line, dogs will stand six feet apart.
- 9. Running orders will be posted as usual, but please socially distance. If you have a smartphone, please take a photo of the running order and results and do not linger near the postings. Running orders & results will also be posted on the IHCUS Facebook Page.
- 10. There will not be self-serve ribbons at this event.

These procedures may change depending on the requirements by Purina Farms and the state of MO

## MASK USAGE & SOCIAL DISTANCING WILL BE ENFORCED!

Any belligerence toward the enforcement of these rules will result in immediate removal from the trial site with no refund provided.

## ALL ENTRANTS MUST BE ADHERE TO ALL COVID-19 POLICIES AND PROCEDURES

- LIMITED EVENT ATTENDANCE: Facilities and events will operate at limited capacity based on St. Louis area guidelines. We will continue to update these as local guidelines allow. For now, spectators are not allowed at events. (Capacity constraints will be adjusted based on current COVID-19 guidelines.)
- ENTRY/EXIT POINTS: Names of registered participants and guests will appear on a check-in list provided to security to allow for entry onto the property.
- PHYSICAL DISTANCE REQUIREMENTS: All event participants and guests must follow appropriate social distancing restrictions of six feet or more from others and avoid physical contact with anyone else, including other pets. Floor markings and signage will continue to serve as reminders to maintain social distancing.
- FACE COVERING REQUIRED: In alignment with CDC guidelines, fully vaccinated guests and employees will not be required to wear masks while on property but will be encouraged to do so indoors. For unvaccinated individuals, masks will need to continue being worn indoors and outdoors while on the property, unless actively eating or drinking. Face coverings are also encouraged for any guests (if applicable) ages 2-4. If for some medical reason you are unable to wear a face covering, we will determine if there is another alternative for you [and others] to safely enjoy Purina Farms. In line with our culture of trust and mutual respect, we will not be requiring proof of vaccination. We do, however, expect everyone to be honest with each other.
- ADVANCE CLEANING PROTOCOLS: Common use items and equipment, including drinking fountains and dog watering stations, will not be available for the time being. Restrooms will be frequently cleaned and disinfected.
- **CHILDREN:** Any children on property must always be accompanied by an adult and supervised at all times. Also, see face covering guideline above.

Purina Farms shall reduce capacity and control the maximum number of event participants and guests in its facilities to 25% of the normally permitted occupancy, in accordance with the current Guidance per the City of St. Louis:
